



TATTOO SERVICE - INFORMATION SHEET

VICKY KHEIRA TATTOO

First off, thank you for your request. This document will provide information about my practice. From the consultation until how to take care of the healing process, Hopefully it will answer most question, but I am available by email to answer some more.

ABOUT ME/ MY PRACTICE

I started tattooing in 2018 while finishing my Bachelor in Fine Arts with a Major in Painting and Drawing. I am currently pursuing a Master in Sciences of Arts to challenge my knowledge about art. Most of my inspiration comes from paintings and nature, while my practice finds itself in a feminist approach. While I will provide my professional opinion, my goal is to make the client feel listened about their needs during the process, from choosing the piece of art until the healing time. My approach to tattooing is based on inclusivity, with the constant research to create a safer space. I consider my relation with the client horizontal, meaning that I am always open to hear what will make the person comfortable. All tattoos are made with coil or/and rotary machine or stick and poke, using quality vegan and sustainable products. Tattoos are personalized to customers in size and placement.

CONSULTATION

A consultation can occur latest one week before the tattoo appointment. It will help the artist and the client to find the right size and placement and determine appropriate price. A deposit is required to secure the tattoo appointment and reservation of the piece of art. This information sheet and health disclosure will be printed and provided to the customer at the consultation or sent by email.

APPOINTMENT

Before

An appointment will be made by the customer and the tattoo artist. Any cancellation in the 48 hours before the appointment might result in a loss of the deposit. It is important before the tattoo appointment to have a good meal, to avoid alcohol/drug consumption at least 24 hours before. For clients having menstruations, it is recommended synchronizing the tattoo appointment outside of the beginning of period to avoid sensitivity to pain. It is also important to mention allergies/health information before the appointment by filling the health disclosure form.



During

If the appointment is long duration (communicated during the consultation), a snack is recommended during the pause. Drinking water is highly recommended. The tattoo artist will check on the state of the customer from time to time to make sure everything is going fine. The artist will listen to their music while tattooing, it is therefore recommended to bring your own music with earplugs. A photo will be taken at the end and posted online and tagged/identified with the consent of the customer.

Aftercare

A second skin can be applied after the service and personalized information will be given for the removal. Every skin is healing differently, but those tips will help heal properly and safely.

DO's

- clean with parfum free and soft soap 1-2 times a day
- moisturize only when necessary, with parfum free cream (for example, with B Panthenol found in Apotheke)
- leave the tattoo breath as much as possible
- contact me for any touch-ups in the 4 months following the service or any questions
- Always use sunscreen when the tattoo is completely heals

DON'T's

- bath or swim for at least 2 weeks
- clean with abrasive or perfumed soap
- keep the second skin for more that 72 hours after the service
- do heavy sport (or anything involving high sweating) for at least 72 hours
- use olive/coconut/any pure oil, pure Vitamin E, Petroleum Gel for moisturizing the skin
- scratch/remove the healing wound during the healing process
